# TON addendum Summary & Request

The Green Fund award 15SP109 for \$5,050 was not all used in FY16. The GA who was managing the award indicated we had received approval to roll over the remaining amount of the award to FY17. However, our department cannot find verification of this approval. To date we have received half of the 15SP109 award of \$2,525.00.

During FY16 & FY17 Touch of Nature spent a total of \$8,115.49 in funds for Environmental Education outreach to SIU students. We are formally requesting the remaining 15SP109 award funds of \$2,525.00 be allowed to be rolled into the 16SP127 award amount of \$2,050.00 to help offset the total that was spent on this initiative.
